The *Texas Bar Journal* is the official publication of the State Bar of Texas. Published monthly, except for August, the *Texas Bar Journal* contains legal articles, State Bar news, features on Texas lawyers, and information on technology and trends in the law. The magazine's webpage, www.texasbar.com/tbj, offers a complete, searchable archive of the magazine dating to its founding in 1938.

The *Texas Bar Journal* has a circulation of 95,000 and is the only publication that reaches every lawyer in Texas. The *Texas Bar Journal* Board of Editors, a committee of the State Bar of Texas composed of attorneys from diverse practice areas across the state, reviews legal article submissions. To ensure that the magazine remains current and functional to its readers, the board typically plans issues six months in advance.

The *Texas Bar Journal* staff — Managing Editor Kevin Priestner, Associate Editor Patricia Garcia, Assistant Editor Judy Marchman, Graphic Designer Tony Garcia, and Advertising Representative Susan Brennan — acts as a liaison between authors and the board. All communication concerning article submissions, review, and publication should be directed to the journal staff.

In addition to legal articles, the *Texas Bar Journal* welcomes articles for two of its columns: Solo/Small Firm and Client Page. The Solo/Small Firm column focuses on addressing the unique practice issues of solo and small firm lawyers. Client Page offers timely legal information for clients of Texas attorneys in a question-and-answer format. The information does not constitute legal advice, but provides information to educate legal consumers.

Due to the large number of legal articles submitted to the Texas Bar Journal, the board of

editors generally takes 60 to 90 days to offer its judgment on each article. After an article has been approved, it is usually published in the magazine within six to nine months.
