OUR MISSION

The mission of the Texas Minority Counsel Program ("TMCP") is to expand and increase opportunities for minority and women attorneys who provide legal services to corporate and government clients and to expose organizations seeking outside counsel to the legal talent found in the minority and woman lawyer community. The program seeks to encourage corporations and government agencies to retain minority and women lawyers from minority, woman, or majority owned law firms.

THE 2006 CONFERENCE GOALS

- ♦ Provide interviewing opportunities to minority and women lawyers for outside counsel employment with corporations and government agencies.
- ♦ Offer an informal environment for participants to meet and network.
- ♦ Present a comprehensive dual-track CLE program designed specifically for (1) minority and women law firm members and (2) corporate and government counsel.

WHO ATTENDS

- ♦ Minority and women lawyers desiring to enhance their opportunities to represent corporations and government agencies.
- ♦ Corporations and government agencies desiring to retain or become more visible to minority and women lawyers in Texas.

INTERVIEWING & NETWORKING OPPORTUNITIES

Attendees of the 2006 TMCP can take part in interviews with participating organizations to discuss outside counsel opportunities. Networking opportunities are made possible throughout the conference in the form of luncheons, receptions, and free-time periods scheduled over the day-and-a-half long event.
