Texas lawyers have the ability to practice law in a self-regulated profession with an independent grievance system. Since the bar's inception, Texas lawyers have retained the right to approve proposed disciplinary rule changes in referenda elections and vote on members of the board of directors, which governs all manner of bar administration, programs, policies, and budget management. FACTS

Lawyers in Texas pay lower membership fees than those in almost every other state where a unified bar performs regulatory functions.¹ The State Bar of Texas has not raised membership fees since 1991, and there are no current plans to increase them.

Lawyers who live in states that have voluntary bars are still required to pay annual licensing fees, most often to government-sanctioned bodies that are charged with the regulation or discipline of the profession.

Texas lawyers pay membership fees as follows:

- Licensed 0 to 3 years = \$68
- Licensed 4 to 5 years = \$148
- Licensed more than 5 years = \$235

Attorneys age 70 or older are exempt from paying membership fees if they have filed a written notice requesting enrollment as an emeritus attorney. If you have questions about emeritus status, please contact the Membership Department at 800-204-2222, ext. 1383.

With some exceptions, attorneys also must pay an annual legal services fee of \$65 imposed by Government Code Section 81.054. This fee is a legislative mandate and is not imposed by the State Bar. The funds are collected and paid to the clerk of the Supreme Court of Texas and remitted to the State of Texas Comptroller. The legal services fees do not fund any State Bar activities.
