Re: Nomination for Chair of the Board of Directors for the State Bar of Texas

Dear Chair Alimohammad:

Please accept this letter as my notice of intent to seek the position of Chair of the Board of Directors for the State Bar of Texas for the year 2018-2019. Pursuant to Section 1.11.02 of the State Bar Board Policy Manual, I am submitting this statement of position setting out my views and strategies related to the issues that I believe will be of greatest significance to the Board and State Bar.

I grew up in a small town in Southeast Texas. After undergraduate and law school, I returned to the same small town and have been practicing law here for the past 27 years. Not only have I always lived in a small town, but up until this year, I have always worked for small firms. Small town/small firm life shaped my view of the practice of law and the State Bar of Texas. Five or six years into my practice, a candidate for State Bar President came to Beaumont and wanted to meet with some young lawyers. I recall telling him that I would certainly support him (he was a friend of a friend), but it really did not matter much to me who became President as I had no idea what the State Bar did or what its purpose was. I worked for a very small firm at that time where the lawyers were not involved in the bar association on a local level, much less on a state-wide level. Participation in anything outside the practice of law was not overly encouraged. Outside of providing CLE, I was not aware of other benefits to being a member of the State Bar. My ambivalence was due to a pure lack of information. I believe there are a vast number of lawyers in Texas with the same experience.

My views have changed drastically over the past 17 years. In 2001 I became active in the Jefferson County Bar Association, eventually serving as President. In 2004 I became active with the State Bar, via the Litigation Council, eventually serving as Chair. I also became a Director on the Board of TADC, where I still serve. Once I became active in both the local and State Bar, I gained an entirely new perspective. The more involved I became, the more I learned what the State Bar was about, the great work it does and the number of programs, benefits and resources offered to not only its members but to our communities. However, it was not until I became a

Director and did my first presentation on the State Bar services that I realized just how much we do and just how much we offer.

I relate the above because while the State Bar is an organization like no other, I will always believe we can do better and we can do more. My primary objective is to reach out to those lawyers practicing in small towns/rural areas and in solo/small firms. Now that I have joined a larger firm (at least larger by Beaumont standards), I now see partners encouraging the younger lawyers to get involved. That is something I never saw with any of my prior firms and I believe it is vital. We must reach out to and engage those in small towns/rural areas and solo/small firms to educate them on all that is available and encourage their involvement. The lawyers in small towns/rural areas and solo/small firms have a unique perspective on the practice of law and they encounter problems different from those of big cities and big firms, and we, as an organization, must listen to those perspectives and be responsive to the problems.

Part of the difficulty we encounter in reaching Texas lawyers is that many live in much smaller towns than mine, in areas that are remote and that have no local bar association. There are just not enough people to support it. That is the struggle we face, to reach those lawyers. We have heard much lately about the “disenfranchised members” and those who feel the State Bar does not do anything to benefit them. I believe this sentiment comes from a lack of knowledge about the State Bar and benefits, programs, resources and opportunities available. It will become a larger problem going forward as we see more and more young lawyers hanging out a shingle and going it on their own. We must do a better job of reaching out to and educating our members about the benefits, programs, resources and opportunities available. Doing so would help change the perception of the State Bar, but more importantly, would serve the greater goal of providing much needed assistance to lawyers in Texas.

We must raise awareness of all the State Bar has to offer. Social media, in this day and age, is certainly helpful, but its usefulness can be limited. We must strive to find new ways to reach the lawyers whom I believe need our help the most. The ability to reach our members is key and we need to focus on more effective ways to communicate with those members in small towns/rural areas and solo/small firms. Personal contact is of vital importance in accomplishing this goal. While I recognize that is not an easy task, it is one we must figure out. The State Bar has to be more approachable and make more of an effort to reach those that in the past have been unreachable, whether through meetings, seminars, small lunches, a traveling “road show” through the more remote areas, etc. As one of my mentors told me in my early years of trying cases, “You never know if something is going to work until you try it. You just have to be bold enough to do it. If it works, great. If not, chalk it up to a lesson learned, move forward and next time, try something else.”

It would be a privilege and an honor to serve as Chair of the Board of Directors. In doing so, I recognize the critical importance of serving not only the Board members and State Bar, but the entire membership. We must have an open forum for voicing our views, opinions, concerns, differences and ideas. My commitment will be to seeing that every voice is heard, as we must begin thinking outside the box to meet the many challenges facing our profession and to accomplish the goals of education and inclusion.

I respectfully submit this letter in support of my nomination for Chair of the Board of Directors. Thank you for your consideration and I look forward to the opportunity to serve the Board.

Dear Chair Alimohammad:

I am seeking the nomination for the position of Chair of the State Bar of Texas for 2018-19. Pursuant to Board Policy Manual Section 1.11.03, I respectfully submit my statement of beliefs and strategies which I consider to be of the greatest significance to the Board and to our Bar in the context of our Strategic Plan for 2018-2019.

I have had the privilege of serving on the Board for two terms. During that time, I have benefited from the excellent leadership of Presidents with great vision and Chairs who demonstrated exceptional diplomacy. If I am elected Chair, I will encourage open discussion from which we can engage in a thoughtful exchange of views and work to build consensus among our members. I will treat all opinions with respect and give everyone an opportunity to be heard while making sure that our meetings are run efficiently such that we maximize what we can accomplish during the time we are together.

I am a great believer that board members can make their most meaningful contribution if they are able to work on issues that are both important to them and that allow them to use their unique talents in a way that benefits our Bar and the public. As a result, I will ask our board members to give consideration to the areas in which they would like to serve and lead and make appointments accordingly.

At a time where discord in our society and in our profession is at an all-time high, I will work with Executive Director Trey Appfel and President-Elect Joe K. Longley to continue to improve our communications with our members. In last year's election, we saw that a considerable number of our members do not believe that our Bar is open to all or transparent in its operations. We need to continue to communicate the fact that the Bar is not a group of insiders or a private club, but instead it is available to anyone who wants to serve. We also need to be transparent in everything we do.

As board members, it is important that we remember that we are ambassadors in our mission to serve the public and our members. The importance of educating the public about the rule of law has never been greater. President Vick has spoken about the diminution in participation by lawyers in holding elected office. Our country was built on, and gained strength from, the many lawyers who have held

public office. I believe that it is important that we continue to encourage our members to be active in serving in all branches of government.

The challenges facing our members are significant. With over 100,000 members, the competition among lawyers is great and the number of clients who can afford our services is small. As the second largest bar in the country, with fewer members than only California, we need to continue to be leaders in innovation. As we all know the Bar, under the leadership of then President Frank Stevenson, launched the Texas Opportunity & Justice Incubator, which Frank fondly named "TOJI," less than a year ago. It is well on its path of achieving its mission to expand access to justice for low-and moderate-income Texans, while at the same time helping our newest members establish sustainable practices that serve this ever demanding population of clients. When our third cohort begins in April, TOJI will be among the largest legal incubators in the world. It truly is bridging the gap between the legal profession and our underserved citizens.

Anyone who knows me knows that I am an extremely hard worker. During my first term as a board member, I was asked to work with Bar staff on a career transition project. I worked with Amy Turner to plan and host a leading-edge program called "Alternative Careers for Lawyers: What are my options and how do I get there?" It was a full day seminar offered in Houston and Austin that sold out immediately. The Bar also provided individual coaching assistance to attendees in the form of three one-on-one consultations after the seminar. The best way for our members to value our Bar is to serve them. I am committed to the continued development of innovative programs like these.

When I served as Co-Chair of the Texas Minority Counsel Program ("TMCP"), I led a change in the way program sponsors were solicited such that our members no longer made cold calls, but instead used their own network to solicit sponsors without fear of opening their personal relationships to other committee members. As a result, in 2009 the TMCP secured its first Presidential (\$10,000) sponsor. The money raised from sponsorships of recent TMCP programs has continued to increase.

In 2011, as President of the Association of Women Attorneys ("AWA"), I created the AWA Premier Women in Law Luncheon, which was designed to honor deserving lawyers, while at the same time raising money for scholarships for Houston based female law students. To date, the luncheon has resulted in the award of approximately \$180,000 in scholarships and recognized the achievements of numerous, primarily women, lawyers. The 2018 luncheon will honor lawyers with a commitment to diversity and inclusion. Among the Honorees will be Phyllis Randolph Frye, a noted advocate for LGBT issues and the nation's first openly transgender judge.

I have attached a summary of my background and leadership experience for your consideration.

I have the time, energy, and dedication to serve as Chair and would be honored and humbled to be elected by my peers to do so.

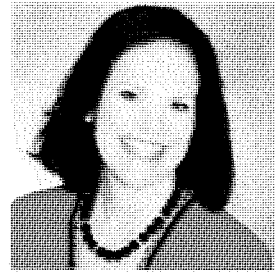
