Bexar County: Attorney Statistical Profile (2017-18)

This report profiles active Bexar County attorney members with membership in the State Bar of Texas as of December 31, 2017. Not all demographic data is provided by every attorney. Over the last 10 years the number of Bexar County attorneys has increased by 23 percent, growing from 5,041 attorneys in 2007 to 6,190 in 2017.
