This report profiles active State Bar of Texas attorney members in Bexar County with membership in the State Bar of Texas as of December 31, 2015. Not all demographic data is provided by every attorney. Separate population totals are provided in italics in each category that is lacking all demographic data. Percentages may not sum to one hundred due to rounding. Over the last 10 years the number of Bexar County attorneys has increased by 24 percent, growing from 4,849 attorneys in 2005 to 6,029 in 2015.
