PROGRAM OVERVIEW & CRITERIA

The Judge Merrill Hartman Pro Bono Judge Award honors a judge, sitting or retired, who has provided exemplary pro bono service, including: outreach to attorneys to increase the quantity and quality of pro bono representation; modifications to court processes to increase access to justice; advocacy on behalf of access to justice; or service as a volunteer judge for pro bono clinics or other pro bono proceedings. The award is named after the late Judge Merrill Hartman of Dallas, a tireless advocate for low-income communities' access to justice. The award is presented at the State Bar of Texas Annual Meeting in June.
