I am writing to you on behalf of myself (see below) and my daughter, Morgan H. Miller, for the sole purpose of obtaining some biographical information about the late Wallace Harland Miller (August 15, 1925-May 15, 1985. Judge Miller was my natural father, and was Morgan's natural paternal grandfather.

Morgan and I know that Judge Miller was born on August 15, 1925; that he enlisted in U.S. Army on/about December 8, 1941, when he was a cadet at the Bryan Military Academy; that on his 20th birthday (8/15/45) he was a commissioned officer of the U.S. Army (Engineers), on duty in the Philippines; and that, following his Honorable Discharge from service, he was graduated in the group of students of the University of Houston (Central Campus) in/about May/June of 1950 which is commonly referred to as "UH's first Law School Class."

Morgan and I have just recently come into possession of copies of original articles clipped from the HOUSTON POST - dated May 19 and May 22, 1950 - which plainly state that, as of May 19, 1950, Judge Miller had "passed the Texas State Bar Examination." Obviously, neither Morgan nor I suspect any "wrongdoing" by anyone - we simply want to know how our Father/Grandfather got to be a licensed attorney in the Great State of Texas in such a double-quick hurry [sic].

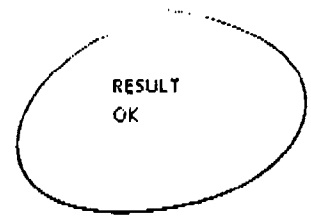
