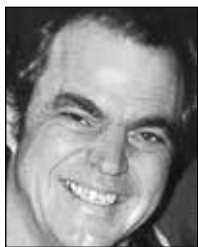


LUCY FORBES

Forbes, 53, died August 25, 2024. She received her law degree from Baylor University School of Law and was admitted to the Texas Bar in 1998. Forbes was an associate of Baker

Botts; a staff attorney with the 14th Court of Appeals in Houston; an attorney with Wright Brown & Close, now Wright Close & Barger; and owner of the Forbes Firm. She was active in the State Bar of Texas, serving as a director of Place 4, District 4 from 2020 to 2023, serving on the Texas Bar Journal Board of Editors, chairing the State Bar Appellate Section, and receiving a Presidential Citation in 2023; active in the Houston Bar Association, where she chaired the Appellate Section Council and is the namesake of the council's Lucy Forbes Excellence in Legal Writing Scholarship; and certified in appellate law by the Texas Board of Legal Specialization. Forbes is remembered for finding joy in the simplicity of things like watching a movie with a loved one, working on an embroidery project, having conversations with a friend or colleague, and the morning breeze on her face during a run outdoors; cooking; and Vinyasa yoga.
