TYLA also showcases its own new projects at the Bar Leaders Conference. TYLA is also working outside of Texas. TYLA's *What Do Lawyers Do?*, which educates high school and college students about the path to law school and a legal career, went national as a project for the American Bar Association Young Lawyers Division. Lacy L. Durham, current chair of the division and a former TYLA director, was instrumental in this effort.

Moving forward, we are looking to increase our partnerships with young lawyers around the country. TYLA has elicited help from other states for its project addressing legal issues unique to military service members going through divorce. So far, we have received contributions from at least two states outside of Texas, and we hope to add more. We also plan to work through the ABA YLD to host an Affiliate Regional Summit with the Young Lawyers Division of the State Bar of New Mexico and possibly other states.
