## Additional Local Bar Services:

### • Attorney Contact Information:

The State Bar of Texas Local Bar Services Department can provide attorney lists that include business contact information. However, attorneys' email addresses, home addresses, home phone numbers, and dates of birth maintained in the State Bar of Texas database cannot be disclosed. It is also important to note that attorneys may elect to be excluded from third-party contact lists.



Local bars may request lists based on the counties they serve and may further specialize it based on the demographic they seek to reach (i.e. gender, year licensed, law school, etc.). The lists will take 3-7 days to process. Lists can be emailed in an Excel attachment or peel-off labels can be mailed.

### • Member Recruitment Email:

The State Bar of Texas Local Bar Services Department will send one membership recruitment email per calendar year on a local bar's behalf to a targeted group of individuals. The email must be used to advertise local bar association membership. Local bar events may be listed as member benefits, but this email may not be used to promote or market a specific event.

To schedule this email, please provide the following:

- Draft email
- Specified target audience
- Bar card numbers for existing members if you choose to exclude them from the email
- Image for the email banner (Width must be 650 pixels or less.)
- Email address for replies

This info will be drafted in our email platform and the association will receive a draft to approve. The drafting process can take up to three to seven business days.
