Accessing Briefs, Pleadings, Motions, & Orders on Fastcase

1. Click "Jurisdiction and Sources" on the right side of the main search bar
2. Under Briefs, Pleadings, and Orders, select the document type
 - a. To search by all document types, select 'All Briefs, Pleadings and Orders'
 - b. To search by a specific county, click the carrot to expand
3. Click Save and Continue
4. Enter search in the search bar
5. Click the magnifying glass to search

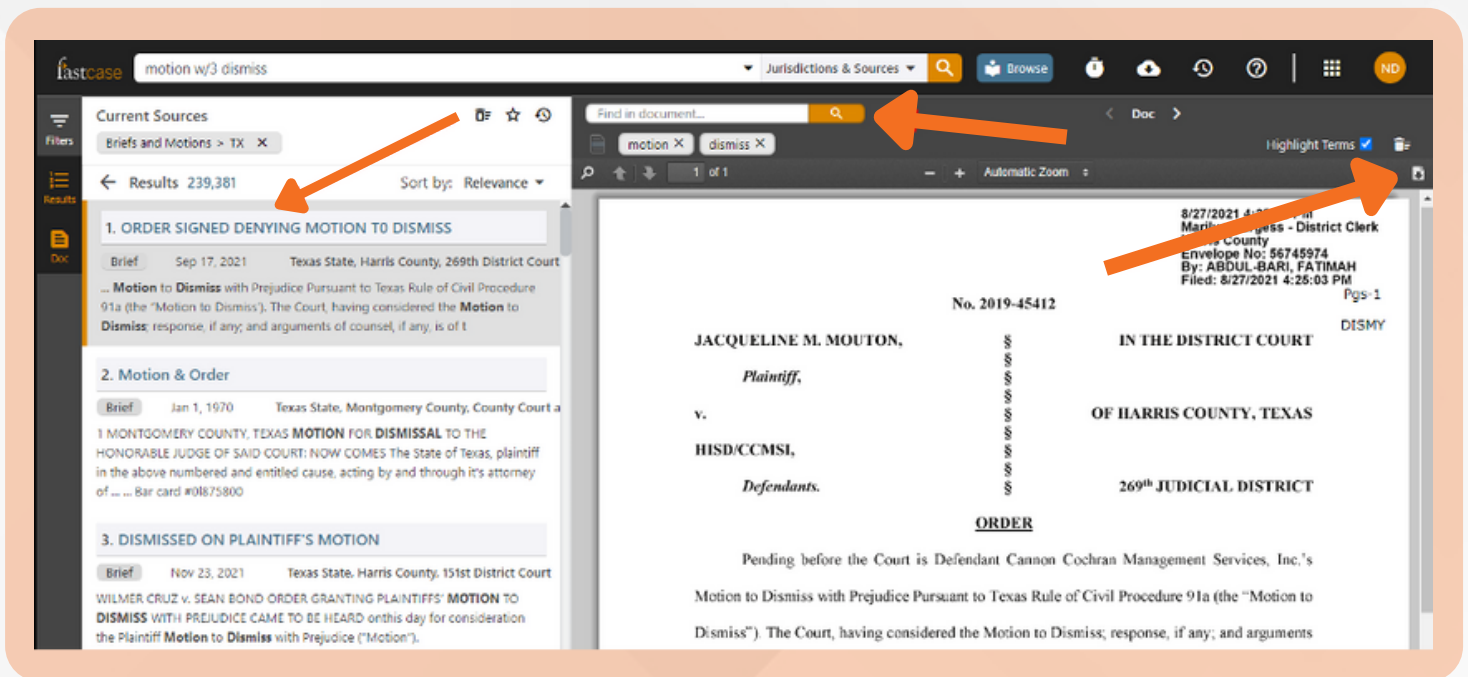
